Your primary key tasks will be to

- monitor Taiwanese HSE legislation development, communicate changes and ensure implementation in our internal HSE Management Systems
- establish and maintain a Chinese language version of relevant parts of our internal HSE Management System
- be responsible for development and maintenance of HSE legal register for Taiwan and supporting the wider organisation with queries and guidance
- engage in dialogue with HSE authorities and other parties on relevant HSE matters including participating in groups and forums
- maintain and coordinate the HSE requirements (including earthquake and typhoon emergency response) for the Taipei and regional offices.
- accompany team members on site visits, HSE inspections and meetings
- input and review data in our internal HSE monitoring system
- ensure development and maintenance of best practice, in cooperation with other Wind Power HSE organisation and other areas of Ørsted Wind Power.

Moreover, you will support the pursuit of improving our HSE performance and safety culture, you will collaborate with our partners, contractors and suppliers to identify HSE focus and improvement areas and participate in relevant HSE industry working groups in Taiwan. You provide input to Management Review, conduct local audits, provide support/guidance on matters such as selection of PPE to be used at sites, HSE training for onshore and offshore personnel, emergency response, etc. You ensure HSE compliance at the Taipei Office and maintain and update the Emergency Response Plan for the Taipei Office and support local emergency response exercises. You participate in incident investigations when required and provide constructive input, as required, to the wider company HSE organisation in the form of lessons learned, case histories and suggested improvements from Taiwanese activities

You are willing to take on a wide and variable range of tasks with a 'can-do' attitude, to support the developing HSE activities in Taiwan and to ensure that key deliverables are met.

Your qualifications and core competences include that you

- have a bachelor's or a master's degree or equivalent
- have extensive relevant work experience within HSE
- 2-3 years' experience from a similar position, or a position in the Ministry of Labour or Environmental Protection Agency.
- Excellent communication skills, enabling you to communicate your messages smoothly and efficiently to stakeholders at all organisational levels, internally and externally.
- Can handle project management and complete tasks and assignments within deadlines.

You understand the importance of and excel in teamwork, across several countries and cultures. Interested in working flexibly across a range of health, safety and environmental areas. Qualifications in internal auditing and experience in conducting audits against OHSAS 18001 and ISO 14001 standards would be an advantage but is not essential.
